



2021 June-August Auto Loan Sweepstakes Official Rules

INSURED BY NCUA. NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR ODDS OF WINNING. VOID WHERE PROHIBITED.

1. To Enter: No purchase or payment of any money is necessary to enter. The 2021 June-August Auto Loan Sweepstakes ("Sweepstakes") begins on June 1, 2021, at 9:00 AM ET and ends August 31, 2021, at 5:00 PM ET. There are two (2) ways to enter the Sweepstakes: [1] Automatic Entry Method: A qualifying Honor CU member will receive one (1) automatic Sweepstakes' entry when they apply in person, on the phone or online for an auto loan, boat loan, RV loan or other toy loan during the Sweepstakes Entry Period. The loan amount approved must be for at least \$7,500; refinances of existing Honor auto loans are ineligible. [2] Alternate Method of Entry: Complete the Alternate Entry Form below or provide your name, birthdate, address, phone number, email, and the words "2021 June-August Auto Loan Sweepstakes" on a plain piece of paper and return to Honor Credit Union, ATTN: Marketing 2021 June-August Auto Loan Sweepstakes, 8385 Edgewood Rd. Berrien Springs, MI 49103. **Only one entry per person allowed, regardless of entry method.** Additional entries received more than stated limitation will be void. All mailed entries must be postmarked no later than August 31, 2021 and must be received by Honor CU by September 7, 2021 at 1:00 PM ET. Honor Credit Union's computer is the official time-keeping device. All entries are the property of Honor CU and will not be acknowledged or returned. Honor is not responsible for entries that are lost, late, stolen, damaged, postage-due, undelivered, misdirected, returned, illegible or otherwise deficient, incomplete, or not received for any reason. Honor, in its sole discretion, reserves the right to disqualify any person tampering with the administration, security, proper play or entry process of this Sweepstakes or otherwise in violation of these Official Rules. Honor CU further reserves the right to cancel, terminate or modify any promotion not capable of completion as planned, including, without limitation, by tampering, unauthorized intervention, or force majeure.

2. Random Drawing: One (1) Grand Prize winner will be selected by Honor CU in a random drawing of all eligible entries received. The drawing will occur on or about September 13, 2021. Odds of winning will be determined by the number of eligible entries received by Honor CU. The winner will be notified on or about September 13, 2021, at the number provided on the entry form or auto loan application. The winner must provide Honor CU with any information, including social security number, necessary to complete IRS Form 1099 or a similar form at the time the prize is accepted to accept the prize or prize may be forfeited. Failure to complete prize acceptance or failure to comply within 14 days will result in forfeiture of prize. If a prize is forfeited, an alternate winner will be selected through subsequent drawing(s) of remaining entries until the prize is accepted. Prizes not accepted by October 1, 2021, will not be awarded.

3. Eligibility: The Sweepstakes is open only to legal residents of the United States who are 18 years or older as of June 1, 2021. Employees of Honor CU, its subsidiaries, affiliates, advertising/promotional agencies, board members, and the immediate families and household members of such persons are not eligible to win. This Sweepstakes is intended solely for viewing and participation in the United States and

shall be construed and evaluated solely under United States federal, state, and local laws. By entering, entrants certify that they meet all eligibility requirements.

4. Prize and Approximate Retail Value: One (1) Grand Prize: Equivalent of 12 monthly auto loan payments, up to \$6,000 total approximate retail value (ARV). Prize amount is determined by the winner's monthly auto loan payment. For example, if the winner's monthly auto loan payment is \$400, the winner would receive a Grand Prize of \$4,800. Similarly, if the winner's monthly auto loan payment is \$250, the winner would receive a Grand Prize of \$3,000. In no situation will the prize exceed \$6,000. If the winner does not have a monthly auto loan payment with Honor CU (including, for example, if the winner entered using the Alternate Method of Entry), the prize amount will be determined by the amount of the winner's monthly auto loan payment with another lender. If the winner does not have a monthly auto loan payment with any lender, the Grand Prize will be \$2,000. The prize is not transferable to another person or entity. No cash redemption or substitution of prize will be made, except by Honor CU in its sole discretion due to causes determined solely by Honor CU, and then for a prize of equal or greater value. Grand Prize will be awarded as a one-time (1) deposit into Honor CU Share Savings Account, or VISA gift card if a Share Savings Account is not available, within approximately twelve (12) weeks after prize confirmation and verification has been completed. If the actual value of the Prize is less than the stated ARV, the difference will not be awarded.
